- The Islamic Chamber of Commerce, Industry and Agriculture (ICCIA) is an affiliated organ of the Organization of Islamic Cooperation (OIC) and represents the private sector of 57 member countries.
- The idea of setting up an ICCIA was mooted in the Seventh Islamic Conference of Foreign Ministers held in 1976 in Istanbul-Turkey, which was approved by the First Conference of the Chambers of Commerce and Industry held in October 1977 in Istanbul, Turkey.
- Its constitution was adopted by the Second Conference of Chambers of Commerce and Industry held in 1978 in Karachi Pakistan.
- The aim of ICCIA is to strengthening closer collaboration in the field of trade, commerce, information technology, insurance/reinsurance, shipping, banking, promotion of investment opportunities and joint ventures in the Member countries.
- The Headquarter of ICCIA is situated at Karachi (Pakistan) and Regional Office is in Jeddah (Saudi Arabia).
