#### SUBJECT: NPIs ENFORCEMENT - MARKETS, MALLS AND BAZARS

I am directed to state that the Home Department, Government of Sindh was pleased to issue strict NPIs for enforcement especially in Karachi Division and Hyderabad District vide order of even number dated 29.08.2021 (copy enclosed for ready reference).

- 2. I am further directed to state that NCOC vide letter No.801/A//NCOC-01 dated 11.09.2021 has communicated that SOPs compliance will be ensured in Markets, Malls and Bazars on 13<sup>th</sup> and 14<sup>th</sup> September 2021 in high disease prevalence cities i.e. Karachi and Hyderabad with special focus on following:-
  - Ensuring that no market, mall and bazar remain open beyond prescribe time limit of 08:00 pm except essential services.
  - b. Ensuring that ban imposed on indoor dining in food courts / food streets is observed.
  - c. Ensuring that only vaccinated individuals (minimum partially vaccinated) are allowed to enter into shopping malls (including shopping mall management, staff, employees of various outlets and customers). Cutoff date for partial vaccination for entry into shopping malls is enclosed vide letter at reference A.
  - d. Ensuring that COVID protocols (mask wearing and social distancing) are adhered to during business timings.
- 3. You are accordingly, requested to please take following measures:
  - i. To formulate appropriate teams for NPIs/SOPs enforcement on 13th and 14th September, 2021.
  - ii. To seal Markets, Malls and Bazars and make arrests on account of gross violations.
  - iii. Share details along with pictorials daily at 08:00 pm as per format attached at Annex A.
  - iv. <u>Media Coverage.</u> National / local media houses to be energized for highlighting NPIs compliance drive / actions initiated against the violators.

NO. SOJI/8-1(04)2020(Stage-4 NPIs): In continuation of this department's order s of even number dated 08.08.2021 & 09.08.2021 and in pursuance of NCOC guidelines vide their letter No.801/A/2/NCOC-01 dated 28.08.2021 for continuation of existing NPIs for high disease prevalence cities especially Karachi & Hyderabad and a relatively milder NPIs regime in other cities /areas of the Province of Sindh, the below mentioned NPIs shall remain in force from 1st to 15th September, 2021. Now, therefore, the Home Department, Government of Sindh in exercise of powers conferred under Section 3(1) of the Sindh Epidemic Diseases Act, 2014 (The Sindh Act VIII of 2015), is pleased to issue the following order for enforcement within the territorial jurisdiction of the province of Sindh:

a.	Business Timings	Market / business activities in Karachi Division and District Hyderabad may continue till 08:00 pm.						
		Other Divisions /Districts of Sindh Province to continue Market / business activities till 10:00 pm.						
		Essential services to continue 24/7 (Pharmacies, Medical Facilities, Vaccination Centers, Petrol Pumps, CNG Stations, LPG shops, Milk / Dahi Shops and Tandoors) and Standalone Grocery Stores, Fish, meat, vegetable / fruit vendors, E-commerce and bakeries. All the managements / staff /eustomers shall follow Covid related SOPs.						
b.	Closed	Closed days will be observed as under during the week

c.	Dining	Complete ban shall continue on indoor dining for Karachi and Hyderabad, however, outdoor dining will be allowed till 10:00 pm under strict COVID protocols.						
		Indoor and outdoor dining will be allowed till 11:59 pm at 50% occupancy for the vaccinated individuals only.						
		Carrying vaccination cards by the guest while dinning out shall be mandatory for to purpose of inspection by the LEAs.						
		Takeaway/drive through and Home Delivery are allowed 24/7, subject to following of all SOPs with staff and delivery personnel duly vaccinated.						
d.	Weddings and related ceremonies	Karachi and Hyderabad There will be a complete ban on indoor weddings and related ceremonies. Outdoweddings and related ceremonies are allowed with a maximum of 300 guests under str COVID protocols till 10:00 pm.						
		Other Divisions /Districts of Sindh Outdoor weddings and related ceremonies are allowed with a maximum of 400 guests under strict COVXD protocols till 10:00 pm.						
Soi.	al aller	Indoor weddings and related ceremonies are allowed with a maximum of 200 guests only for the vaccinated individuals under strict COVID protocols till 10:00 pm.

c.	Religious	There will be complete closure of shrines in Karachi Division and District Hyderabad. However, shrines in other parts of the province of Sindh may be opened at the discretion of Divisional /District Administration concerned in consultation with Health as well as Auqaf and Religious Affairs Department Sindh.				
ſ.	Cinemas	There will be complete closure of cinemas throughout the Province of Sindh.				
g.	Gatherings	Ban is imposed on all types of indoor gatherings including cultural, musical / religious / miscellaneous event. However, outdoor gatherings will be allowed for a maximum 300 individuals under strict COVID protocols.				
h.	Sports	Complete ban shall continue on contact sports (Karate, Boxing, Martial Arts, Rugby, Water Polo, Kabaddi & Wrestling).				
i.	Gyms	Indoor gyms will be allowed for vaccinated individuals only.				
j.	Office	Karachi and Hyderabad Routine Normal office working hours for public / private offices will continue; however, attendance level shall be reduced from 100% to 50 %.				
		Other Divisions /Districts of Sindh Routine Normal office working hours with 100% attendance.				
k.	Public Transport	Public Transport may ply on sanctioned routes with Occupancy level of up to 50% seating capacity, subject to following of all SOPs with staff duly vaccinated.				
		Ban is imposed on all type of snacks serving to the passengers during journey by the transport services.				
l.	Railways	Railway services will continue to operate with 70% occupancy under strict COVID protocols subject to following of all SOPs with passengers and staff duly vaccinated.				
m.	Recreation	All amusement parks, water sports & swimming pools shall remain closed in Karachi division and District Hyderabad, however, public parks may remain open under strict COVID protocols.				
		In other Divisions / Districts of Sindh amusement parks, water sports & swimming pools, public parks may remain open under strict COVID protocols.				
n.	Extended Lockdowns	District Administration may impose Broader lockdown for specified areas within the jurisdiction with stringent Covid protocols based on risk assessment. District Administration shall implement targeted SLDs / mSLDs.				
0.	Mask Wearing	Wearing of Mask shall be compulsory at public places.				
p.	Tourism	Tourism will be allowed for vaccinated individuals under strict COVID protocols.				
q.	Meal / Snacks during Travel	Ban is imposed on serving of meals / snacks during inflight journey for domestic airlines.				
r.	Inbound Passenger Policy	Current Inbound passenger policy will continue till further orders.				

# **ENFORCEMENT**

2. This order, and the SOPs / directions issued there under shall be enforceable with effect from 01.09.2021 to 15.09.2021 untill revised / recalled / amended / modified earlier if the periodical review of the COVID-19 situation so warrants.

- 3. Secretaries of respective departments viz. Industries, Transport, Labour, etc. who are entrusted with regulation/control of respective activities / function related to above as well as respective Divisional Commissioners are empowered under Section 3(1) of said Act to issue further orders, directions, notices to put this order into effect in letter and spirit and to clarify further for implementation purpose (but not allow what is not permitted or disallow what is permitted). Any action required to be taken under this order may be taken if deemed necessary by taking representatives of concerned Industrial / Transport Association (to be nominated by the concerned President) into confidence.
- 4. A team of officers / inspectors of administration, Industries, Transport, and Labour department duly authorized by Deputy Commissioners or Secretaries concerned may check the place any time for compliance of directions issued by Government.
- 5. Deputy Commissioners, Additional Deputy Commissioners, Assistant Commissioners, Mukhtiarkars, Labour Officers, Officers of Transport Department, Officers Incharge of Police Stations as well as the personnel of Law Enforcement Agencies not below the rank of Inspector Police (or of equivalent rank for other Law Enforcement Agencies) are empowered under Section 3(1) of the said Act to take any legal action on any act in contravention of this order or directions / notices issued there under and including action under Section 188 of Pakistan Penal Code 1860. Further legal action can also be taken under relevant Labour, Industrial, Motor Vehicle and other applicable laws.

- Apropos, SOPs compliance will be ensured in Markets, Malls and Bazars on 13th and 14th September 21. All federating units are requested to formulate appropriate teams for SOPs compliance with special focus on following:-
  - Ensuring that no market, mall and bazar remain open beyond prescribe time limit of 08:00 pm less essential services (Petrol Pumps, Pharmacies, Medical Facilities, Vaccination Centres, Milk / Dahi Shops and Tandoors etc).
  - Ensuring that ban imposed on indoor dining in food courts / food streets is observed. b.
  - Ensuring that only vaccinated individuals (minimum partially vaccinated) are allowed C. to enter into shopping malls (including shopping mall management, staff, employees of various outlets and customers). Cutoff date for partial vaccination for entry into shopping malls is enclosed vide letter at reference A.
  - d. Ensuring that COVID protocols (mask wearing and social distancing) are adhered to during business timings.
- Markets, Malls and Bazars will be sealed and arrests will be made on account of gross 2. violations. Details along with pictorials will be shared with NCOC daily at 08:00 pm as per format attached at Annex A.
- Media Coverage. National / local media houses will be energized for highlighting SOPs compliance drive / actions initiated against the violators.
- Details of sectors for SOPs compliance on 15th September 21 will be intimated by NCOC in due course of time.
- Soft Launch Obligatory Vaccination Regime. Obligatory vaccination regime will be 5. launched in phases (as intimated vide reference A). First phase i.e. Soft Launch (1st to 15th September 2021) will be used for extensive communication and advertisement at prominent places (entry / exit points of markets, malls and bazars).
