Open Joint Stock Company "Borisovskiy zavod medicinskikh preparatov" (JSC "BZMP") is the leading manufacturer and exporter of medicines in the Republic of Belarus. The enterprise was founded in 1965.

The main activities of JSC "BZMP" are production of drugs for human use (customs code 3004) in the form of:

- solutions for injections in ampoules;
- powders for preparation of solutions for injections in vials;
- tablets;
- soft medicines (ointments, creams, gels);
- medicines in hard gelatinous capsules;
- alcohol solutions, tinctures.

At the present day the enterprise uses more than 300 technologies, which allows us to produce a broad range of drugs covering more than 200 medical products in 12 pharmacological groups:

- group A: digestive tract and metabolism;
- group B: blood and blood forming organs;
- group C: cardiovascular system;
- group D: dermatologic medicines;
- group G: urogenital system and reproductive hormones;
- group J: anti-infective agents for systematic administration;
- group L: antineoplastic and immunomodulating agents
- group M: locomotor system;
- group N: nervous system;
- group R: respiratory system;
- group S: sensory processing disorder drugs;
- group V: other drugs.

For production of our drugs we use equipment of the following world-known companies: IMA, Marchesini (Italy); Rota, Pharmatek, GUK, Bausch & Strobel (Germany); DGM, Watertown (China); BWT (Poland); Dividella (Switzerland); Norden (India); Romaco (Belgium); Senjong (S. Korea); Killian (China-Germany).

The enterprise supplies its products to the domestic and foreign markets. The plant supplies medicines to Russia and other CIS countries. The company has business partners in Afghanistan, Iraq, Latvia, Lithuania, Estonia, Bulgaria, Macedonia, USA, Somalia, Egypt, Yemen, Vietnam, Cambodia and Mongolia. The total number of countries where we supply our products is 24.

In 2016 the output of JSC "BZMP" products was more than 116 million USD. Export shipments in 2016 amounted to more than 56 million USD.

At the moment JSC "BZMP" carries out registration of its products in Iraq, Vietnam, Mongolia, Sri Lanka, Serbia and Cambodia.
